Re: Labor Code Section 3201.5 Renewal of Letter of Eligibility:
Laborers' Health & Welfare Trust Fund for Southern California

Dear Mr. Matyas and Mr. Sheh:

I am pleased to inform you that, based on a review of the documents and materials submitted on April 23, 2024 and May 17, 2024, I have found that the parties to this agreement continue to meet the eligibility requirements of Labor Code section 3201.5 (Section 3201.5). The terms and conditions for continued eligibility, and the recordkeeping and reporting requirements outlined in prior letters of eligibility, remain in full force and effect. Please note this letter is not a determination that the collective bargaining agreement, in its entirety or in part, is in compliance with Section 3201.5.

This letter permits you to continue to maintain an alternative dispute resolution program for disputes about claims for workers' compensation benefits. It also permits you to maintain an exclusive list of providers of medical treatment, medical evaluation, and/or vocational rehabilitation. As provided by California Code of Regulations, title 8, section 10204, subdivision (a), please submit a letter annually outlining any changes to your program.
